#### 1. INTRODUCTION

#### 1.1 - Letter to suppliers

Dear SUPPLIER.

This Specific Requirements Letter updates and replaces the previous document issued by DRiV of Jun / 2016. Clauses 8.4 Control of processes, products and services provided externally from IATF 16949: 2016 require the organization to ensure that the product purchased complies with the specified acquisition requirements. The type and extent of control applied to the supplier and the product purchased must depend on the effect of the product on the subsequent realization of the product or on the final product.

The organization shall evaluate and select suppliers based on their ability to supply products in accordance with the organization's requirements. Criteria for selection, evaluation and reassessment must be established. Records of the results of the evaluations and any necessary actions, arising from the evaluation, must be kept. #### 4.6.1 – Launch containment process

#### **Driv NVH Cotia:**

The contention time period will begin with the first part sent after PPAP. The specific requirements of the end user in relation to containment must be followed. The containment will continue for at least 90 days after the initial shipment and no less than 10 shipments without defects after the SOP or containment will be extended until the PCAs are completed and no defects are found in the containment (at the discretion of the DRiV installation). For launch containment labeling guidelines, please contact your DRiV Buyer.

#### 4.8.1 - PPAP submission OE / AM

PPAP submission is mandatory, and whenever requested by the purchasing team, through the TITAN system or e-mail.

#### 4.8.19 – OE Client Specific Requirements (DRiV & End User)

The supplier must maintain evidence of the deployment of DRiV requirements and DRiV Customer Requirements in the Supply Chain. It is necessary to show that all items of the requirements have been evaluated and broken down, so it is expected to identify the methodology used and the reference of the DRiV requirement versus the correlation of the supplier's internal QMS procedure and status.

#### 4.8.20 - Process Audit Requirements

DRiV requires a self-assessment before the on-site audit. The self-assessment form will be made available by the Quality team of DRiV suppliers.

DRiV may ask suppliers, if necessary, for a shutdown / start up assessment, in order to reduce the risk of quality problems during the resumption of production.

The periodicity of supplier audits will be carried out according to the audit schedule of each DRiV division, considering the risk analysis of suppliers.

#### 4.10.1 - Delivery Quality and Performance

#### **Driv NVH Cotia:**

The quality indicator is monitored through the SCORECARD / IQF, sent monthly to suppliers via e-mail

#### **Driv Ride Control Mogi Mirim:**

Logistics performance is monitored monthly by the logistics team through the supply service index. The logistics team will periodically keep the supplier aware of its performance.

#### 7. PACKING

#### **Driv NVH Cotia:**

In addition to the requirements described in the global manual, suppliers receive instruction I.7.5.5.08 - Specification for Packaging of Material Purchased for Production

#### **Driv Ride Control Mogi Mirim:**

According "DRiV - Supplier Requirements Manual"

#### 7.1 – Supplier Responsibilities

The supplier must consult the buyer of his commodity and request the packaging pattern of the DRiV unit that will receive the material.

Evidence of the packaging standard must be submitted together with the PPAP documentation, with due approval. It is recommended to make it available in the C-Folder of the Titan system..

#### 7.7 – Labeling and Identification

Barcode identification labels should be used, according to the standard labels defined by each business unit. Specific cases must be dealt with by the buyer or quality representative of DRiV.

#### 8. ENVIRONMENTAL HEALTH AND SAFETY

#### 8.1 - EH&S commitment

The supplier must provide and maintain an updated copy with the current date of the Operation License and letter of legal requirements signed via Titan in the C-folder. It is up to the supplier to keep this document updated with the State Competent Body.

#### 9. CORPORATE RESPONSIBILITY FOR THE AUTOMOTIVE SUPPLY CHAIN

#### 9.1 - Corporate social responsibility

#### Legal liability:

The DRiV supplier is included in the supply chain of the largest automakers in the world, and will answer legally about the quality of the component or service provided for DRiV. The supplier's responsibility for the component or service provided for DRiV will be extended to the final consumer, with the application of current laws.

#### Civil responsability:

As DRiV assembles components and semicomponents that are supplied to automakers in the world market, it must meet the requirements of Brazilian and international automakers called "Civil liability on automotive product". This requirement also applies to your entire supply chain.

Regarding the products that DRiV manufactures, there is civil liability, while for the components acquired by DRiV, the supplier is responsible for the item, and the supplier must have a safety representative, trained in accordance with the product for the PSCR (Safety of the Product). Product and Compliance Representative) the certificate must be maintained and updated by the supplier in the database TITAN - FOLDER "CONTACT INFORMATION".
